for audio and video recordings and will destroy the recordings after they have been observed in supervision.

### **Monitoring/outcome tools**

Counselor behavior evaluation form. Counselor self-review of the counseling session. Peer evaluation form. Client feedback. SKA supervision evaluation form. Supervisor working alliance inventory form. Performance assessment rubric. Video, literature and website review forms. Monthly and quarterly summaries. **Monitoring of documentation is required for approval of supervised clinical hours.**

### **Session Fees and Length of Service**

Supervision sessions are typically (50) minutes long. We will discuss and agree on session length and will make changes if necessary. If you are unable to keep an appointment, please try to contact me at least 24 hours before your appointment. If you find you cannot do this due to circumstances beyond your control, such as an accident or sudden death of a family member, we will discuss arrangements. If you find that you cannot make an appointment and you do not call at least 24 hours prior and are not experiencing an emergency, you may be responsible for paying for the session you missed. Sessions are focused on acquiring full licensure, the 12 core functions of substance abuse, use of the DSM, ASAM criteria, exam preparation, scope of practice, the North Carolina healthcare system, development of counselor skills, and career planning. Supervisee agrees to maintain a supervision binder and provide the supervisor with up to date information and paperwork. Group and individual sessions are available. The sessions may take play with face to face video live feed such as Vsee, Facetime, etc. Fees are \$70 per session. Prepay specials are available and PayPal invoicing may be used.

### **Confidentiality**

All of our communication becomes part of the supervision record, which is accessible to you upon request. I will keep confidential anything you say as part of our supervision relationship, with the following exceptions: (a) you direct me to disclose information to someone else, (b) it is determined you or your client are a danger to yourself (themselves) or others; this includes child or elder abuse, (c) I am ordered by a court to disclose information, (d) information necessary to provide to NCSAPPB.

If court-ordered I will provide the least possible information to protect your and the client's information. I will make every effort to cite privileged communication when asked any question. I will likely use benefits from my liability insurance or a personal lawyer when ordered to appear in court.

In relation to supervision sessions, I will only inform your employer of the supervision relationship and generic curriculum unless you provide me written permission to share results and supervision outcomes and information.
